## Important Note 重要提示

- ◆ This is a self-certification form provided by an account holder to SDG Securities (HK) Limited ("SDGS") for the purpose of automatic exchange of financial account information. The data collected may be transmitted by SDGS to the Inland Revenue Department for transfer to the tax authority of another jurisdiction. 這是由帳戶持有人向山金證券(香港)有限公司(「山金證券」)提供的自我證明表格,以作自動交換財務帳戶資料用途。山金證券可把收集所得的資料交給稅務局,稅務局會將資料轉交到另一稅務管轄區的稅務當局。

## Warning 警告

It is an offence under section 80(2E) of the IRO if any person, in making a self-certification, makes a statement that is misleading, false or incorrect in a material particular AND knows, or is reckless as to whether, the statement is misleading, false or incorrect in a material particular.
